I represent and warrant that my art/drawings are my original work which was created, conceived, and produced without the assistance of any third party.

I hereby waive any right that I may have to inspect and/or approve, photograph, likeness, portrait, or picture; the copy or story that may be used with it or the use to which it may be applied, the right to approve the finished product in which my likeness, story or voice appears, and I hereby release, discharge and save CLIENT and its officers, directors, agents, employees and contractors harmless from any liability which otherwise might be incurred by virtue of any blurring, distortion, alteration, optical illusion or use in composite form, whether intentional or otherwise, that may occur.
3. I waive any right to royalties or other compensation arising or related to the use of my story, image, or recording.
4. By signing this Release, I understand this permission signifies that photographic, audio or video recordings of me may be electronically displayed via the Internet or in any public setting.
5. I understand that no change, addition, deletion or modification in any manner to this contract is valid or accepted by CLIENT.

I also hereby release and discharge CLIENT from and against any and all claims, demands, or liabilities of any nature whatsoever I may hereafter be entitled to assert, including but not limited to any death, loss, damage, injury, or property damage, resulting from my participation in this photo shoot/art production including but not limited to liabilities for invasion of privacy, appropriation of likeness or defamation. I understand that I am participating in this photo shoot/art production at my own risk.
